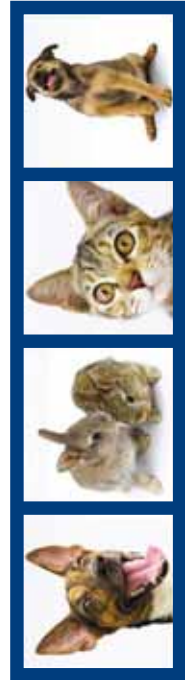

The SPCA is a registered animal welfare charity with IPC status. It depends mainly on donations to carry out its various services.

Your donation can help the Society continue running its 24 hr emergency service, investigation of cruelty complaints, collecting unwanted pets, rehoming of animals, conducting educational talks and a clinic for sterilisation/treatment of stray animals.

To make it convenient for donors to contribute to SPCA, the Society accepts donations via interbank GIRO. Interested donors may give a standing instruction to his/her bank for the deduction of a fixed sum of money each month from his/her account, to be paid to the SPCA. We look forward to your support. Thank you.

### GENERAL INFORMATION ON HOW INTERBANK GIRO WORKS:

1. COMPLETE THE INTERBANK GIRO FORM OVERLEAF and return it to the SPCA.
2. The Giro deduction will be reflected as "DNT" in the Pass card/Current Account Statement or Passbook when it is presented for updating.
3. If any clarification is required over the amounts deducted, please contact the SPCA Giro Officer at 6287 5355
4. Termination of interbank GIRO deductions must be made in writing by the donor to his/her bank.
5. Changes of amount or account must be made in writing by the donor to his/her bank.
