## **Renewal of Sponsorship**

Thank you for renewing your sponsorship. We are truly grateful.

### **What will your donation provide?**

Your donation will be used for the care of the animals who are accommodated in your sponsored kennel/cattery/nursery and their maintenance during the year.

As an acknowledgement, we will place a plaque with your message (e.g. "In Memory of .....") above your adopted kennel/cattery/nursery.

You will also receive regular updates of some of the animals who passed through your kennel/cattery/nursery on their way to a new & loving home, as well as a small write-up on each of these animals.

### **How much does it cost?**

Each kennel/cattery/nursery & its occupants cost will remain the same as previous years – for upkeep, food, water, toys, bed .... all the things a stray or unwanted animal needs to be active and healthy.

Donation needed to sponsor a kennel/cattery/nursery are as follows:

**Kennels (per):** \$3,500 for a year; \$5,000 a year for supersized kennels.

**Cattery (per lot):** \$1,500 for a year; \$3,000 for 2 years and \$4,500 for 3 years.

**Nursery (per lot):** \$1,500 for a year; \$3,000 for 2 years and \$4,500 for 3 years.
